The companies act as the registrar for the personal data we collect for documenting material purchase activities. The registrars are responsible for the personal data provided to them and their processing. Data protection is all about trust, and protecting your privacy and personal data is of the utmost importance to the Companies. For this reason, we collect your personal data only to the extent that we need it to maintain and fulfil our legal obligation to verify the measures related to money transactions. In this data protection statement, the principles that the Companies implement in the processing of personal data have been discussed.

Purposes of personal data processing

Personal data is processed on the basis of the consent of the registered person or the customer relationship between the Company and the customer or other factual connection, in which case the legal basis for processing is the legitimate interest of the controller, especially for the following processing purposes:

- Documentation of business relationships
- Electronic customer communication
- Analysis and statistics
- Implementation and development of customer service and operations

The companies consider the creation of a customer relationship as an agreement for the collection of register data.

Groups of personal data to be processed, information content of the register

The companies process the following personal data or groups of personal data necessary for the purpose of use:

- Contact information (name, company/organization, address, phone number and email address)
- Information regarding the customer relationship (invoicing and payment information as well as product and order information)
- Information about your purchases (personal identification number or social security number)
- An individual's photo from an ID can be added to the register

Regular sources of information

The information to be recorded in the register is regularly received from the customer in a buying/selling situation verbally on site, by e-mail or by telephone.

Data retention period

We keep the customer's data only as long as it is necessary to fulfil the purpose of using the personal data of the customer relationship in accordance with the legislation in force at any given time. However, we may be obliged to retain some of the customer's personal data in order to comply with accounting or other mandatory legislation even after the end of the customer relationship or other basis for processing personal data.

Personal data processors

The employees of the companies whose work tasks require the processing of personal data can process personal data in accordance with the applicable data protection legislation. A separate confidentiality and data processing commitment has been made with them. Termination of the employee's employment removes the right to process personal data.

Data transfer outside the EU or the European Economic Area

Data is not transferred outside the EU and the European Economic Area

Disclosures of data

There are no regular disclosures of data. The companies do not sell or rent the registered person's personal data to third parties. Information is disclosed to third parties only in the following cases:

- We can hand over the customer's personal data in a manner required by the requirements of the competent authorities or other parties, based on the applicable legislation at any given time.
- If the customer has separately given his consent to the electronic direct marketing of the Companies partners, the user's data can be disclosed to carefully selected partners for marketing purposes.
- If we merge or otherwise organize our operations, the user's personal data may be disclosed within the organization.

Principles of registry protection

The manual materials concerning the register are stored in protected premises. Digitally stored and processed information is in databases that are protected by firewalls and passwords.

Technical data protection has been utilized in the implementation of the pages, which aims to ensure that the entered information remains unchanged and is only available to persons entitled to the information.

Only those employees of the Companies whose job duties require it have access rights to data processing in the register. Editing and reading the data in the register requires personal identification in the system. The registry is regularly backed up.

Rights of the registrant

In accordance with the EU Data Protection Regulation 2016/679, the data subject has the right to access data, request correction or deletion of data, limit processing, transfer data from one system to another, and object to the processing of personal data.
